Working Group Reports</b></p>	<p><b>Objectives WG</b></p> <p><b>PRESENTATION</b></p> <ul style="list-style-type: none"> <li>♦ Tara Szkorupa reported on the Objectives WG meeting and provided an overview of changes to the ‘Towards a Policy’ and ‘Recommendations’ documents, including language for inclusion in the fall letter to the Minister and ideas for inclusion in a future letter.</li> </ul> <p><b>DISCUSSION</b></p> <ul style="list-style-type: none"> <li>♦ Council would like to see stronger, more direct wording (e.g., “enact legislation” not “commit to enacting legislation”). Recommended timelines should be included to indicate Council’s sense of priorities, recognizing that government processes can take time.</li> </ul>

### **ACTIONS/NEXT STEPS**

Tara Szkorupa and Mike Demarchi to provide an updated draft with more assertive wording in the Recommendations for inclusion in the letter to the Minister.

### **Funding WG**

#### **PRESENTATION**

- ♦ Jasper Lament provided an overview of the BC Wildlife Federation motion to support doubling the surcharges on hunting and species licences; the Conservation Officer Service proposal to review and increase fines under the Wildlife Act. These would create a small uplift to dedicated revenues (maybe 1% of the funding gap). BCTF hunting surcharge in 2019/20 was \$2.6 M. Recommendations of the Funding WG were:
  - To support the BCWF proposal to double the HCTF surcharge on hunting and species licenses for resident hunters and non-resident hunters and to review and increase the surcharge on a regular basis;
  - To support the Conservation Officer Services request for increases to *Wildlife Act* fines, and request that the Ministry consider dedicating the funds for wildlife penalties (or a new surcharge on such penalties) to HCTF (or similar body) so that they can directly support wildlife and habitat stewardship; and
  - To continue conversations with the HCTF to better reflect Indigenous needs and processes.
- ♦ Ontario has a dedicated fund for fish and wildlife fines.
- ♦ Funding principles to be included in letter to Minister.

#### **DISCUSSION**

- ♦ Council sought clarification on the impact on the funding shortfall.
- ♦ There is an opportunity to explore tag licences and royalties as a larger source of funding. Dedicated funding from court awards can also be explored.
- ♦ Future Directors Reports should report on progress towards new sources of dedicated funding.
- ♦ Letter to Minister needs to be clear that these changes are not all Council will be recommending.
- ♦ Wildlife Act requires fees / royalties for opportunity and/or killing of wildlife. Discussion of rail companies and permit requirements. Railroads have to report wildlife kills as a permit condition. Improving information and reporting is being explored.

Wildlife Dialogues</b></p>	<p><b>PRESENTATION</b></p> <ul style="list-style-type: none"> <li>♦ Nancy Wilkin presented the proposed approach to the two Wildlife Dialogues (Indigenous dialogues and stakeholder dialogues).</li> <li>♦ Council members will help with facilitation of breakout groups.</li> </ul> <p><b>DISCUSSION</b></p> <ul style="list-style-type: none"> <li>♦ Agenda items should be reversed (1. How can we support the paradigm shift to “wildlife first”; 2. How can the Province and Indigenous Nations expand partnerships to deliver wildlife stewardship.)</li> <li>♦ Language for questions needs to be refined; needs to avoid repeating what has already been achieved and inform about what has already been recommended.</li> <li>♦ Invitees should be sent the background information (T4W Strategy, Director’s Report, summary of Council actions to date). Consider additional background documents (e.g., Old growth strategic review recommendations; FRPA Intentions paper)</li> <li>♦ Important to ask how we can bring wildlife forward as a priority.</li> </ul> <p><b>ACTIONS/NEXT STEPS</b></p> <ul style="list-style-type: none"> <li>♦ Luke Doxtator to provide updated language and input for the second question.</li> <li>♦ Judith Cullington to send out a “save the date” notice to Council members and invitees.</li> <li>♦ Nancy Wilkin and Judith Cullington to prepare an updated agenda for the dialogues.</li> </ul>
<p><b>6. Wildlife Act Review</b></p>	<ul style="list-style-type: none"> <li>♦ Dennis Paradine noted that the Ministry has initiated a process to review the Wildlife Act. This will consider: <ul style="list-style-type: none"> <li>○ The scope of review, how to reflect impacts of Blueberry River First Nation (Yahey) decision, shared decision making and co-management, etc.</li> <li>○ Addressing gaps in the current legislation, e.g., having wildlife objectives.</li> </ul> </li> <li>♦ Anticipated timeline of policy review during 2021-22, with legislation in 2023.</li> <li>♦ Ministry will be seeking input and advice from MWAC</li> </ul>
